## 2004 Recreational Boat Slip Waiting List Application - Fee \$20

NOTE: Pursuant to the Town of Harwich Harbor Management Plan, adopted January 26, 2004, specifically, Section 3.3 entitled, Eligibility for Mooring Assignment and/or Mooring Waiting List, any boat owner wishing to have his/her name placed on either the slip or mooring waiting list must do so annually prior to April 1<sup>st</sup> and so advise the Harbormaster in writing and pay the applicable fee to the Town of Harwich." Further, the affidavit at the bottom of this application must be signed and dated.

It is agreed that any person wishing to have his or her name placed on the waiting list(s) must annually before April 1<sup>st</sup> so advise the Harbormaster in writing and pay him (the Town of Harwich) a fee of \$20. This twenty dollar (\$20) annual fee is non-refundable.

It is agreed that the name on the waiting list(s) shall be advanced from year-to-year only if the annual fee is paid. Mooring space will be assigned to parties whose names have been on the list longest, as space becomes available.

It is further agreed that when a mooring becomes available it will be occupied by a boat owned by the person whose name appears on the list. Mooring space is non-transferable, other than surviving spouse, and non-subleasable.

I hereby grant the Harbormaster permission to place a person-to-person collect call to me if mooring space should become available for my boat.
