### Application

This plan is based on the premise that at appropriate times volunteers can bolster government resources should a water based emergency occur that involves looking for a person(s) lost on the waters of Nantucket Sound. Should a water based emergency occur you may be contacted by the Harbormasters Office as a boat owner / volunteer in **AVERT** to supplement available government resources by joining a search party under suitable sea conditions. Because of probability of low visibility It is critical that all participants in this group contact and update the Harbormasters Office (or USCG) during any such exercise and shall follow the regulations governing this program.
